Accreditation Program Update

CALA Food Laboratory Accreditation Announcement

CALA is very excited and very proud to officially report that CALA has now culminated a series of discussions with the Canadian Food Inspection Agency (CFIA). The result of our discussions is a joint agreement covering the accreditation of laboratory testing conducted under legislation that is enforced by the CFIA. This joint agreement provides laboratories with increased options for accreditation, while for the first time, effectively expanding CALA's accreditation services beyond its traditional environmental scope.

Applications for accreditation of a laboratory's food testing scope can be made to the CALA accreditation department beginning immediately. An official joint public news release from CFIA and CALA will follow in due course.

5 | **Guidance on the new release of 22nd edition of Standard Methods**

Q. *The 22nd edition of Standard Methods (hard copy) was just released. Do I have to update all my SOPs to reflect this change?*

A. The requirement in the standard, Section 5.4.2 is as follows: “The laboratory shall ensure that it uses the latest valid edition of a standard unless it is not appropriate or possible to do so”.

The intent of this requirement is that laboratories are not using methods that are out-of-date or obsolete. It is expected that as laboratories are doing method reviews or internal audits that they are comparing their standard operating procedure (SOP) to the most current version of the reference method, and looking for changes to the reference method. For example, in the 21st edition of Standard Methods, there were significant changes to the BOD method.

Let’s take the case of two labs: Lab A simply updated all their SOP’s so that the method reference for Standard Methods says “Standard Methods, 22nd Ed.”. Lab B’s SOPs still refer to the 21st edition of Standard Methods but Lab B has objective evidence that they have started the process of reviewing the newest version of Standard Methods and comparing it to their SOPs. Which lab is most meeting the intent of the standard?

For 2012, you should at least start the process of reviewing the newest version of Standard Methods to see if any of the committee approval dates have changed; our understanding is that if the committee approval dates have not changed between the 21st and 22nd editions, there were probably only editorial changes - if any. If, however, the committee approval date has changed, there are technical changes. So, those are the methods which require a higher level of effort. Standard Methods also acknowledges that the process of updating the online version is still in progress. As with any transition period, it is recognized that time will be needed to address some of the changes and issues that arise.

Control Charting for Laboratories

This one-day course is designed to give a review of control charting for Laboratories including: statistics, charting, upper & lower control limits, plotting and reaction plans, chart analysis and problem solving use root cause analysis techniques. It is designed to give trainees an understanding of how and why control charts are such a powerful tool for tracking and improving quality and process control.
