SHEILA MCMEEKIN

September 19, 1944 – July 28, 2013

Sheila was the Assessments Manager from 1997-2000 when CALA was still known as CAEAL (the Canadian Association for Environmental Analytical Laboratories, Inc.). This was a period of rapid growth for CAEAL, and Sheila was instrumental in helping to transform the organization from basically a one-person operation to the organization that we are today.



4 | Sheila was born on September 19, 1944 in Vancouver, BC to John and Eleanor McMeekin. Her only sibling Linda arrived four years later. In 1952 the family moved to LaCañada, California, and then returned to Vancouver three years later to stay. Sheila graduated from Sir Winston Churchill High School and went on to study Chemistry at the University of BC, obtaining her BSc with Honours in 1965. She was passionate about her career and over and above her work with CALA, highlights included work with Beak Consultants Ltd., Ontario Hydro, and the Standards Council of Canada.



She learned to play the violin, and was also very active in sports. She spent happy summers in Vernon where she taught swimming at Okanagan Lake. At UBC she was an active member of the Varsity Outdoor Club. Soon after graduation she embarked on a big adventure, starting with a cruise to New Zealand. She went on a long adventure in the South Pacific in a 60 foot sailboat with a crew of 8, and did not return home until she had also toured through many Eastern countries, arriving back for her sister's wedding in 1972.

She enjoyed her apartment in the West End of Vancouver and was glad to be back there for her parents and long-time family friends. Sheila made many lasting friendships over the years. She treasured the times they spent together, both locally and on many trips. Many CALA assessors kept in touch over all these years, and got together with her when they were in Vancouver. She took great interest in her nephew and niece, and in all her relatives' and friends' children.

Together they shared the fun of biking the Stanley Park Seawall, swimming in the ocean and beach pool, eating fish and chips while watching out for the seagulls, the midsummer fireworks, camping in her VW van, outdoor music festivals, and Christmas plays on Granville Island.

She went on wonderful trips with special friends over the years. An early trip to Egypt with Rosie started her love of camels and her camel collection. Special last trips were to Ireland and Scotland in 2010, a Mediterranean cruise in 2010 and to Texas in 2011. The 2010 Winter Olympics were a highlight that she shared with friends, too. At home, she organized special picnics to bring her whole group together and all who attended them will remember them fondly.

Sheila remembered everyone's birthday and special anniversaries and sent cards and treasures from home or from her travels. She loved nice long lunches out with friends, but also literature and quiet reading time. Maeve Binchy was a favourite Irish author, who wrote so well about human nature and peoples interrelated lives. Sheila thought that culture, roots and belonging were very important and spent long hours archiving the family history when she could no longer travel. In each box, she placed the Chinese proverb: "To forget one's ancestors is to be a brook without a source, a tree without roots".

Many people have said recently she was the best friend they could have had, and they wrote about her positive attitude and her courage and pragmatism in facing cancer. She spent more time with her sister in the last two years and they shared many special lunches. She achieved much in her lifetime, and will be missed greatly by her family, friends and colleagues.

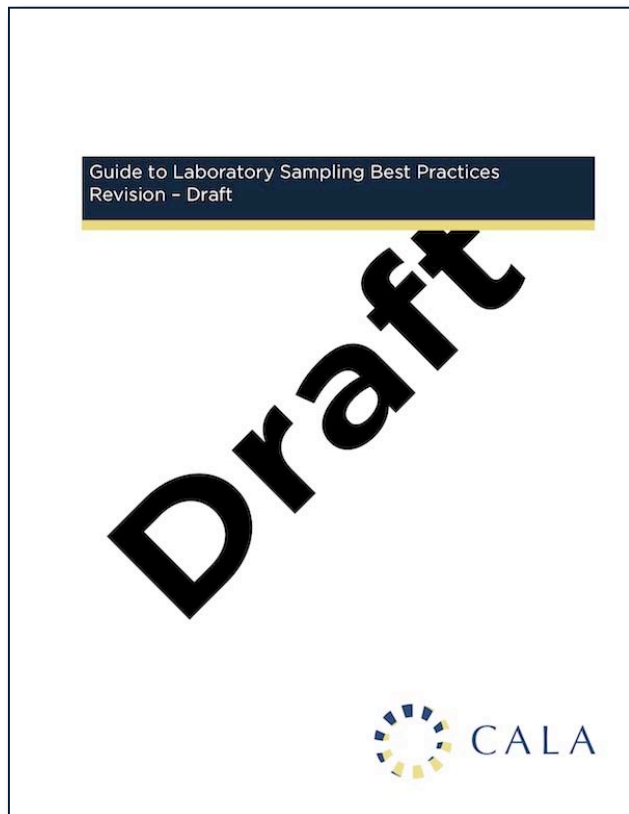


6 | CALA DEVELOPING GUIDE TO SAMPLING BEST PRACTICES

Official Request for Stakeholder Input Next Week

The tagline that accompanies the CALA logo, speaks of “Building Laboratory Excellence”. In our ongoing consultations with the laboratory community, we have heard it said many times, that even if the analytical process is carried out flawlessly, the accuracy of any test result depends on the quality of the test sample received by the laboratory.

Since sampling is such a critical input to analytical testing laboratories, CALA is working to establish a baseline document (Guide) of consistent practical knowledge (Best Practices) from a variety of sources on the topic of sampling. The proposed guide will only concentrate on the aspects of sampling that occur prior to the sample arriving at an analytical laboratory.



Once the Sampling Best Practices Guide is complete and made public, sampling documentation will be made available through the use of hyperlinks from within the Guide. The goal is to create a single electronic source Guide that will connect readers to a range of practical information on the topic of sampling.

We have done some preliminary work, however CALA stakeholder input is now required!

- When you receive our official request in the coming week, please review the attached Draft Table of Contents for the proposed Guide and submit electronic copies of any documentation that you believe is appropriate for inclusion under each/any content area.
- Please copy and forward the request to any of your colleagues/contacts who have knowledge/expertise in this area for their input, or send CALA their names and contact information for follow up.

Please note that all contributors will be listed in the Acknowledgements section of the Guide (unless otherwise instructed) and every care will be taken to ensure that the authors of any submitted documentation

will be fully and properly referenced.

Once we've had a chance to review and compile submissions, we will provide a more complete draft for stakeholder review and input.
