SCOPE EXTENSIONS BY DOCUMENT REVIEW

Laboratories may be able to extend their accreditation based on a document review (see A06 – CALA Accreditation Program, Policies and Procedures). The table (below) outlines the steps in this process, and target timelines. As well, any "new" appendices on a routine assessment that require immediate accreditation for customer or regulatory purposes may be handled outside the normal assessment process and considered a "scope extension by document review"; in this scenario, laboratories will be invoiced a "scope extension administration fee" (see P02-02 – CALA Program Description – Fee Schedule).
